UNDERTAKING

WHEREAS:

PURSUANT TO SECTION 36(1) OF THE *HEALTH PROFESSIONS ACT* THE INQUIRY COMMITTEE HAS REQUESTED STEVE WIENS TO ENTER INTO CERTAIN UNDERTAKINGS AS FOLLOWS:


STEVE WIENS

Undertakes as follows:


1. Not to repeat the conduct that was the subject of the complaint and to further undertake pursuant to section 36(1)(b) and (d) as follows:
2. He will comply with the *Health Professions Act, Opticians Regulation, College Bylaws, Standards of Practice and Code of Ethics.*
3. To supervise all non-registrants at the Crystal Vision location.
4. To have all Crystal Vision staff participate in an education seminar conducted by the College by January 15, 2016, and will pay half of any costs incurred by the college associated with the seminar.
5. To participate in two records review sessions, at his own expense, three months after the education seminar and one year after the education seminar.
6. To review training procedures and create a training manual that includes a section on regulation and unauthorized practice. A copy of this training manual must be provided to and approved by the College of Opticians of British Columbia by January 15, 2016.
7. To have all new and current employees sign a form stating that they understand the regulations that govern Opticianry and unauthorized practice. This form will be provided to and approved by the College of Opticians of British Columbia by January 15, 2016.
8. To pay half the costs of the investigation to the College in the amount of \$2166.64 by January 15, 2016.
9. To work with Stacey Wiens to provide the College, within 30 days of the undertaking, a full list of patients who may have been the subject of unauthorized practice (the "list"). The registrants must telephone all patients on the list using a script provided by the College, informing the patients that they may have been the subject of unauthorized practice. The calls must be completed by January 15, 2016. Lastly, the registrants will cooperate with an audit by

a College appointed inspector who will follow-up with a yet to be determined number of patients on the list.
