To comply with the *Health Professions Act, Opticians Regulation, College Bylaws, Standards of Practice* and *Code of Ethics*.

To review, with a person designated by the College, the recommendation letter issued by the College for conducting independent automated refractions as outlined in the *Opticians Regulation* Schedule and the College's *Standards of Practice* section 4 and 13, before December 31, 2020.

Agree to publication of the complaint disposition on the College website for a period of 10 years pursuant to the *Health Professions Act* section 39.3(1)(b)
