UNDERTAKING AND CONSENT ORDER

WHEREAS:

PURSUANT TO SECTION 36(1) OF THE *HEALTH PROFESSIONS ACT* THE INQUIRY COMMITTEE HAS REQUESTED MICHAEL LOUGHEED TO UNDERTAKE NOT TO REPEAT THE CONDUCT WHICH WAS THE SUBJECT MATTER OF THE INVESTIGATION AND TO CONSENT TO OTHER ACTION.

A. I, Michael Lougheed undertake as follows:

1. To comply with the *Health Professions Act*, Opticians Regulation, College Bylaws and the Professional Standards of Practice;

B. Until such time as the Inquiry Committee removes these conditions, I, Michael Lougheed undertake as follows:


1. To refrain from conducting automated refractions;
2. To remove all signage related to automated refractions and "eye examinations" at Imperial Optical;
3. To discontinue any print or other advertising stating or suggesting that automated refractions can be performed at Imperial Optical;
4. To remove from public view any certificate or document that suggests that he is certified to conduct automated refractions;
5. To agree to and cooperate in a record review to be conducted by the College including a mandatory follow-up session;
6. To successfully complete the on-line jurisprudence assessment required of candidates for certification as refracting opticians;

7. To participate in an interview with the Registrar/Deputy Registrar of the College in relation to the subject matter of the jurisprudence review;
8. To deliver to the College, a copy of updated templates for all forms required by the College Bylaws for the performance of automated refractions;
9. To deliver to the College, within 14 days, or such other as period as agreed by the Registrar, a list of all patients who have received an automated refraction or "eye examination" at Imperial Optical since I was first certified to do automated infractions. This list will include contact information for each of the patients.
